**VILLAGE CODE AMENDMENTS** At their June 12, 2023 meeting, the BHV Board of Trustees voted to make amendments to the BHV Code.

The proposed Code amendments can be reviewed, and a copy is obtained at the BHV Clerk’s Office in the Village Hall. Residents may comment on the proposed Code amendments:

**BHV SERVICES GUIDEBOOK FOR RESIDENTS** This guidebook provides useful information for all residents of the Village and to understand what services are provided, how they are performed, and what guidelines and procedures exist for the safety and maintenance of our community and the team that serves it. **AT-HOME-RECYCLING PILOT** Recycle collection starts Thursday, July 6<sup>th</sup>. Ensure your receptacle is accessible to Village staff by 7:30am as Village staff will make only one attempt to collect your recycling. Bins that don't align with the signed agreement **WILL NOT** be emptied.

- The bins must only contain approved recycling products including, papers, plastics, glass, and metals (cans). **No trash allowed!!!**
- Recycling materials must be clean and dry. No liquid of any kind can be in the cart, including rain/snow.
- The bins lid must be completely closed.
- Corrugated cardboard **IS NOT** included—this will continue to be collected by BHV staff on regular trash days.
- The bin may not be overflowing; the lid must shut completely.
- Recyclables need to be loose (no trash/plastic bags – as these will clog the recycling machine at the recycle facility.)
