FALL CLEAN UP Rake it or leave it...Here's what to do with your yardful of leaves...

Rake it! The BHV staff will pick up leaves for homeowners who rake their own leaves. Wait until just before collection day. <u>Please do not bag leaves for pick up</u>. Put them in piles along the driveway or roadway. Never rake them into or near storm drains, ditches, creeks or the river. Decaying leaves use up the water's oxygen, harming aquatic inhabitants.

Leave it! Mulch leaves by running over them with your lawn mower at next cutting. Leaves and grass clippings are the best fertilizer for your lawn.

- > Separate out sticks/branches from the leaf pile. These will clog up the leaf vacuum.
- ➤ The staff will pick up leaves/sticks/brush **as time permits**. Pick up will not occur on trash and recycle collection days.
- Remove leaves from catch basins and roadside drains to keep water off the roadways.

BHV WATER COMMITTEE At its meeting on Monday November 13, the Village Board of Trustees will consider raising the existing water rate of \$5.99 per 100 cubic feet (CCF) of water. (A CCF is 748 gallons). The Village Water Committee has recommended an increase to \$7.99 per CCF (or about 1 cent per gallon) to cover recent costs, some of which were unanticipated, to maintain and repair the Village water tower and well equipment. The rate increase also will help pay for the expected costs of replacing the ageing 4-inch water lines on Colliston, Corrie, and Hillspur Roads within the next several years.

The proposed rate of \$7.99 per CCF compares to Ann Arbor Township's current rate of \$8.48 per CCF. Other local municipalities charge variable CCF rates depending on volume of water used, and various fees in addition to a per-CCF rate, so it's not easy to compare our rates with our neighbors' rates. However, the Water Committee has put together a chart showing what a typical volume of water usage would cost per month across 12 neighboring municipalities, taking into account those rates and fees. It's available from our Deputy Clerk before the November 13 Board meeting, and copies will be available at the meeting.
