BOARD OF TRUSTEES MEETING Monday June 10, 2024 6:00 PM Walter Esch Hall

Among other business items, the meeting will include a <u>public hearing</u> for a wall permit for 200 Barton North Drive. The application is available for public inspection at the Clerk's Office.

Public comment may be submitted in writing to Barton Hills Village prior to the meeting, or in person during the meeting. The public may attend the meeting in person or watch live on Zoom (view only). The Zoom link and passcode will be available on the Village website homepage at bartonhillsvillage.org (click on the video icon).

The Board of Trustees agenda and board packet are posted on the website on the Friday prior to the Monday meeting. Meeting minutes for all boards are also posted on the website. Click the "BOARDS" tab at the top of the homepage.

BHV ELECTION Five seats on the nine-member BHV Board of Trustees will be up for election this November. Candidates for the four-year terms must:

- --be registered voters in Barton Hills Village,
- --submit nominating petitions with the signatures of at least 20 but not more than 30 registered voters in Barton Hills Village, and
- --obtain nominating petitions and other information from the Deputy Clerk. Please note that the Ann Arbor Township office administers all elections for BHV residents.

The deadline to file candidate nominating petitions is **4:00 PM**, **Tuesday July 23**, **2024**. That sounds like a long way off, but it is a firm deadline. Petitions are available now, and the Township staff greatly appreciates it when paperwork is submitted well before the deadline. This also offers the candidate time to correct any errors or provide additional information.

County Clean-Up Days are events where Washtenaw County residents can recycle and dispose of many household items including electronics, household hazardous waste, bulky waste, appliances, and scrap tires. There are typically five events each year held in different locations spread out around Washtenaw County. Washtenaw County residents may attend any of the events.

Registration will be required to attend any County Clean-Up Day event. The specific location and event map will be provided after registration is completed. Visit https://www.washtenaw.org/2414/County-Clean-Up-Days to register for an event.

RESIDENT WORK / CONTRACTOR NOTICE Per the Village ordinance, the following activities are prohibited if they produce clearly audible sound beyond the property line of the property on which they are conducted:

- The operation of power tools or equipment between 6:00 p.m. and 8:00 a.m
- Construction, repair, remodeling, demolition, drilling or excavation work at any time on a Saturday, Sunday or federal holiday <u>and</u> between 6:00 p.m. and 8:00 a.m. Monday through Friday.
